Westchester Corporate Cup 5K Race

Race Date and Time: Thursday, August 8 at 6:30 PM Sharp! Times: Timed 5k (3.1 miles) run or walk (not timed).

Location: Glen Island Park (use Glen Island Approach for GPS), Weyman Ave, New Rochelle, NY 10805. Race begins and ends at Pavilion 1 and will wind around the scenic loops of the park. Parking is available and included with your registration.

Competition: Race is open to the public. Runners can compete as individuals or as part of a corporate team, but not both. We will recognize the top three corporate teams; the top three women and men individual runners under 40; and the top three men and women individual runners over 40. Teams are gender-neutral and are comprised of three team members.

Registration and Entry Fee: Race-day entry fee is \$40. For those who register by or before August 3rd the entry fee is \$35. To obtain a free race series t-shirt, you must register by 7/31/2024. Participants can register online. You can collect t-shirts and race numbers on race day beginning at 5:00 PM on race day. Pre-registration is strongly recommended!
